Cancellations and Refunds

Transportation, lodging, meals, entertainment and other services are contracted on behalf of the various travel suppliers (airlines, cruise lines, land operator, etc.) on a partially refundable basis depending on the date a traveler may cancel their plans to travel. The cancellation fees and calculations set forth below will apply. The organizing host (Arlie Francis), within two working days of receiving a cancellation notification in writing from a registered traveler, request on the traveler's behalf all refunds applicable from service suppliers and/or land operator (Sar El Tours, Israel). When the organizing host receives any refund from the service suppliers or land operator engaged for this tour, the organizing host will post a refund check to the traveler within two working days following the receipt of any said funds. Any such refund will be a part of and not in addition to the Cancellation and Refunds schedule set forth below.

- * 90 days or more prior to departure - a full refund less a \$100 per person processing fee will apply
- * 89 - 60 days prior to departure - forfeiture of \$1,000 per person deposit
- * 59 – 30 days prior to departure -- a cancellation fee of 50% of the tour cost
- * 29 - 15 days prior to departure -- a cancellation fee of 75% of the tour cost
- * 14 days or less prior to departure – a cancellation fee of 100% of the tour cost
- * In the event that a traveler must leave the tour once it has departed, no refund will apply to any unused services, including but not limited to flights, accommodations, touring, meals and/or transportation.
